A new concept of residency

3 years financing to residency holders

20 days minimum each projet in residency

Each residency holder: 2 residencies a year
minimum

International and national companies

The residency holder should give to selected projets:

Travel

Accomodation + food

Techniqe & technicians

Grant to companies to pay their work

Artists payed (Mandatory, trough the grant)

At least 1 mentor/tutor of recognized fame/capacity





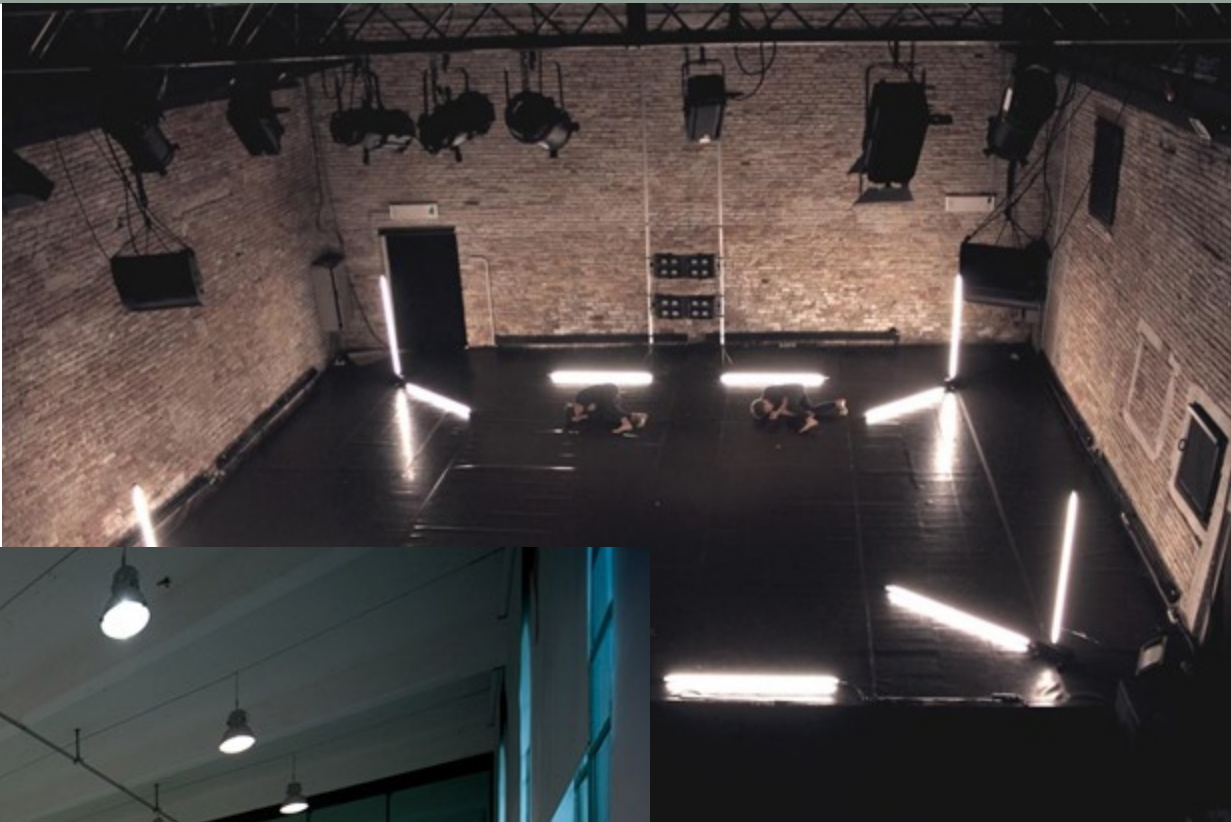
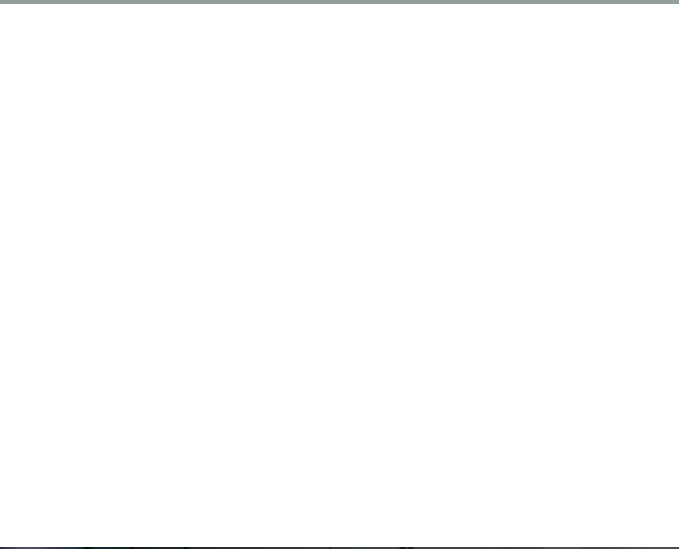

What kind of residency?

For the first time in Italy it is created a space and time for

EXPERIMENT.....

- Different languages
- Complex and articulate projectuality
- Testing new forms of collaboration and partnership
- Research. No expected outcome. No need for creation
- Time. Residencies can go on in the network for the whole 3 years period

High potential

The residential activities can have different objectives and different outcomes. They can be:

- Finalized to the development of a single projet
- Finalized to develop a particular research
- Finalized to support a company to whom we want to propose the interaction with a particular mentor
- Intended to develop the territorial relationship
- Intended to develop actions of audience development and engagement
- Intended to experiment on new models of creation
- Intended to Increase the potential of co-creation and co-project with local artists

The Network

76 Artistic Residencies in 12 regions (exactly 11 regions and 1 Autonomous Province)

27 of them multidisciplinary with at least one yearly circus residence in each year

2 specific on circus,

1 mainly oriented on street arts + circus and dance

2 general meetings each year, each in a different region, to confront, exchange, and make visible holders' places and projects in residency

REGIONS INVOLVED IN 2015: 11 +The Autonomous Province of Trento
IN JANUARY 2016 **SARDINIA** ENTERED TOO, BRINGING REGIONS TO 13, AND

The Budget

Estimated average 30-50.000 € for each residency. Minimum 10.000 € in Toscana on 19 residency holders, maximum 144.000 in Friuli-Venezia Giulia on 1 residency holder (Piemonte 60.000 on 5 residencies of which 1 separate mayor financing -140.000?- on International Center for Excellence of Dance/Lavanderia a Vapore)

Total on the residency programme:

Approx estimated between 3 to 4 millions euros (data to be confirmed)

of which

45% Regions 25% own residency holder sources 30% State

Example: Piemonte, 60.000 € on each residency holder, of which 45.000 from State/Region and 15.000 € of cofinancing by holder himself

The actions

Action A: support to independent companies. Approx 60% of the budget. At least 2 residencies of minimum 20 days

Action B:

Year one-interaction with the territory (population, local artists, other projects, etc)

Year 2 and 3 – interregional exchange: at least 2 residencies hosted in residency in year 1 and 2 by other residencies from other regions

Visibility platform Many kind of actions possible

Action C:

Year 2 and 3 (year one not mandatory) interregional programming of residencies outcomes from other regions – diffusion – networking

Many kind of actions possible

Each residency holder (Example)

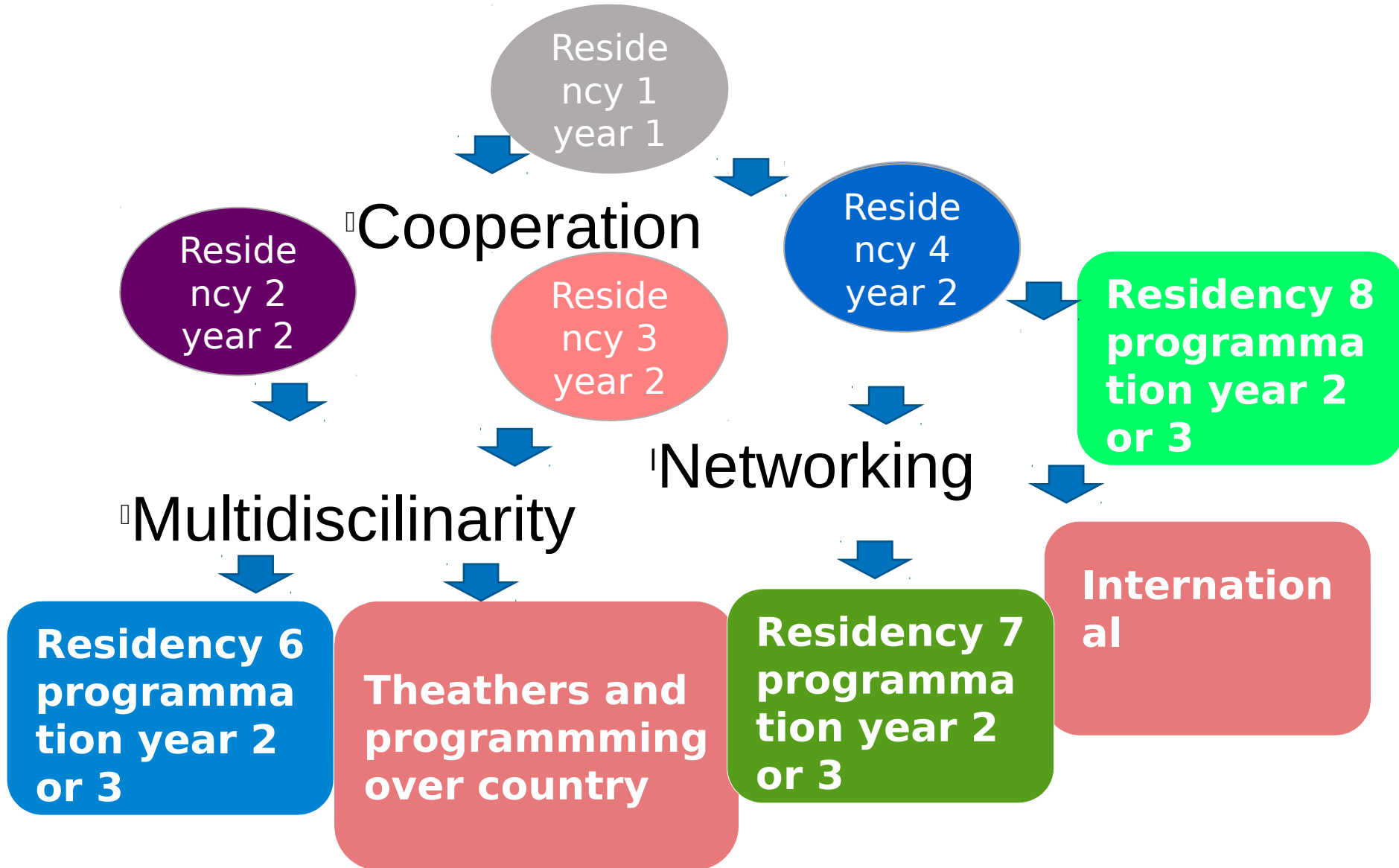
Year 1: 2 to 8 residencies + programming of own residencies

Year 2: 2 to 6 new residencies + 2 residencies coming from other interregional residencies. 2 to 8 outcomes programmed coming from other residencies:

Year 3: 2 to 8 residencies of which at least half coming from other interregional residencies. 2 to 8 outcomes programmed coming from other residencies

- 3 YEARS SPAN PROJECTION (Simplified)



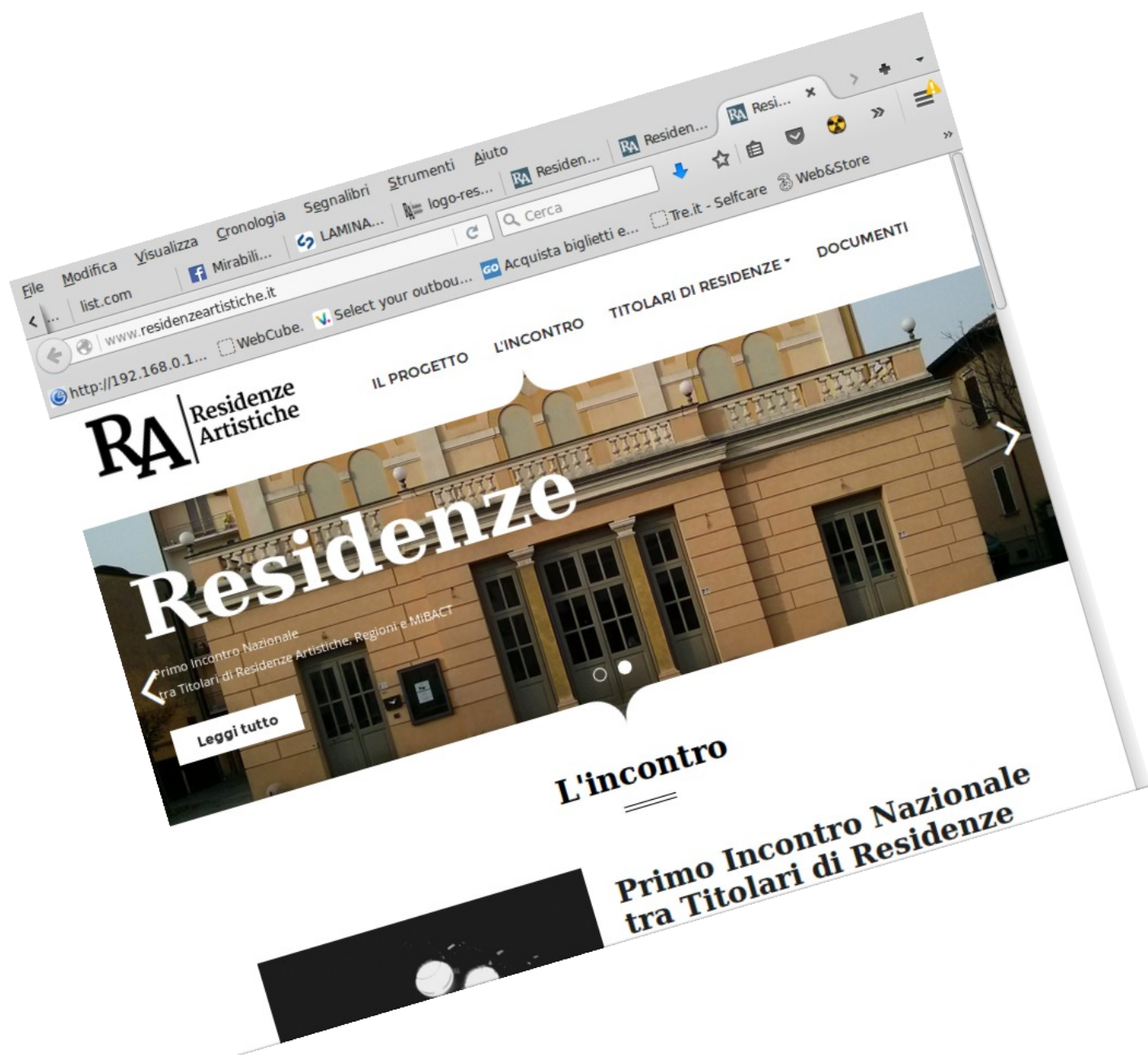
From 2016, 2 or more regional circuits will be multidisciplinary residency holders with..... circus!

- National or regional spaces
- Programming approx 800 to 1200 shows each year
- Circus. From 2016 at least 10%
- Approx 100 circus shows could be programmed by each of the 2 in small and big theatres all over their region!

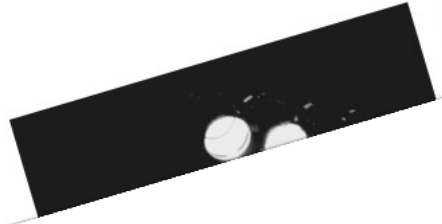

THE FUTURE

With this innovative law, the Italian Government, in our opinion, wants to reach the following objectives:

- Connect the Italian territory on a cultural level
- Connect Italy to Europe
- Stimulate the rise of a new emerging generation of innovative artists.
- Stimulate the development and refinement of new languages, of multidisciplinary and cross-contamination and reach new audiences
- Support and increase the action, (counting on a functional network of residency holders supporting creation), of it's new and innovative law on theatre.

Notes: the application of this law is still being discussed, although it is applied since July 2015, and is being refined upon practical implementation and confrontation between holders of residency, the regional governments and the Ministry of Culture - MIBACT. At the moment the confrontation is really open-minded, and the higher institutions are listening and responding with great attention to all the problematics involved into the application of a new law.
